HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE TEAM RAINBO SPEED SKATING CLUB, its administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS,

DEMANDS, LOSSES, OR DAMAGES ON MY ACCOT]NT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OFTHE..RELEASEES,,OR OTHERWSE,INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSTIMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releases WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

I FURTHER UNDERSTAND THAT THIS AGREEMENT DOES NOT TERMINATE UNLESS IN A WRITING SIGNED BY BOTH AN ALTTHORIZED OFFICER OF TEAM RAINBO SPEED SKATING CLUB AND ME, BUT I WILL BE ASKED TO SIGN A NEW COPY OF THIS AGREEMENT EACH YEAR TO REFLECT MY UNDERSTANDING AND ACKNOWLEDGEMENT OF THE TERMS AND CONDITIONS CONTAINED HEREIN.
